



All students shall agree to follow this Dress Code. In accordance with ITCA's statement of faith, all students will be expected to dress in accordance with their biological sex. Students are required to uphold a standard of a good example to glorify God. Students must be ready and properly dressed with an ITCA uniform prior to entering the school bus or school property.

For Special Events, such as Graduation, Senior Trip, galas, dinners and school-related activities, students must dress modestly. Outfits must not be form-fitting. Clothing must be below the knee, with no slits above knee level. Any makeup worn at school-related events must be in natural/neutral colors only.

Dress Code infractions will result in disciplinary action. Please note the list of Infractions below.

### **MALES**

- Polo shirts with school logo must be purchased at school.
- Long pants: black, khaki or navy blue. No joggers or jeans allowed.
- Must wear a belt and socks at all times.
- Closed shoes. All shoe styles will be subject to approval by School Administration.
- Hair: Long hair, haircuts with designs, or hair colors that we consider inappropriate, are not allowed. Students who dye their hair with a color that is not appropriate for ITCA, will not be allowed to attend school until the color is removed. Facial hair: Beards of any type are not allowed.
- Necklaces, bracelets, piercings or other jewelry, may not be visible to staff or fellow students on campus (including school bus and parking area). The use of watches is allowed (the school will not be responsible for any lost or stolen items). Smart watches are strictly prohibited.
- Coat, jacket and backpack designs are subject to approval by the Administration.
- PE Uniform: Sneakers, school logo shirt, and long pants or shorts below the knee (pants/shorts colors: black, navy blue or dark gray). Only elementary students (K-5) may wear shorts. The PE uniform is mandatory on days assigned for PE and is part of the PE class grade.

### **FEMALES**

- Polo shirts with school logo and Skirts must be purchased at school. No jean skirts allowed.
- Must wear socks at all times.
- Closed shoes. All shoe styles will be subject to approval by School Administration.
- Hair: haircuts with designs, or hair colors that we consider inappropriate are not allowed. Students who dye their hair with a color that is not appropriate for ITCA, will not be allowed to attend school until the color is removed.
- Necklaces, bracelets, piercings or other jewelry, may not be visible to staff or fellow students on campus (including the bus and parking area). The use of watches is allowed (the school will not be responsible for any lost or stolen items). Smart watches are strictly prohibited.
- Coat, jacket and backpack designs are subject to approval by the Administration.
- PE Uniform: Sneakers, logo shirt and school uniform skirt. The PE uniform is mandatory on days assigned for PE and is part of the PE class grade.
- Nails: The use of nail polish in any color is not allowed with the exception of clear. If the student has acrylic nails or any other type of false nails, the length of the nails should be medium. The school will determine if it is appropriate.



## **DRESS CODE INFRACTIONS**

Violation of the Dress Code will lead to disciplinary action.

### First Infraction:

- A verbal warning will be given to the student.

### Each Additional Infraction:

- The student will serve detention. Parents will be notified.

### Excessive Infractions:

- Parents will be called in for a conference with the Principal.

### Special Events Violations:

- Students will not be allowed to participate in the graduation or other event unless they adjust the attire or makeup
